

THE DELTA VACATIONS TEAM VACAY TRAVEL ADVISOR SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

By participating in The Delta Vacations Team Vacay Travel Advisor Sweepstakes (the “Sweepstakes”), each participant (each, an “Entrant”) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Delta Vacations, LLC (the “Sweepstakes Sponsor”) and US Sweepstakes & Fulfillment Co. (the “Sweepstakes Administrator”), which shall be final and binding in all respects.

1. **ELIGIBILITY:** The Sweepstakes is not open to the general public and is only open to travel advisors who are authorized third-party sellers of Delta Vacations products, who are legal residents of the 50 United States, including the District of Columbia, and who are age 21 or older at the time of entry. Void in Puerto Rico, Guam, the U.S. Virgin Islands, all other U.S. Territories and Possessions, outside the U.S., and wherever else prohibited by law. Employees of the Sweepstakes Affiliated Entities (as defined below), the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

By entering, each Entrant acknowledges and agrees that his/her participation in the Sweepstakes may be subject to, or prohibited or restricted by, his/her employer’s policies and regulations and that the Entrant is solely responsible for review of, and compliance with, any such policies or regulations of his/her employer.

2. **SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes begins at 9:00:00 AM Eastern Time (“ET”) on Tuesday, April 16, 2024 and ends at 11:59:59 PM ET on Wednesday, April 24, 2024 (the “Sweepstakes Period”). The Sweepstakes Sponsor’s computer is the official timekeeping device for this Sweepstakes.
3. **HOW TO ENTER:** During the Sweepstakes Period, visit www.DeltaVacationsAdvisorSweeps.com and follow all entry instructions to complete the entry form in its entirety and submit to receive one (1) entry into the Sweepstakes (the “Entry”). **Entries must be received during the Sweepstakes Period to be eligible. There is a limit of one (1) Entry per person.** All Entries become the property of the Sweepstakes Sponsor and will not be acknowledged or returned. Entrants are subject to all notices posted online including but not limited to the Sweepstakes Sponsor’s Privacy Policy, which can be found at <https://www.delta.com/us/en/legal/privacy-and-security>.
4. **PRIZE/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:** There is one (1) grand prize (“Grand Prize”) available to be won. One (1) Grand Prize winner (the “Winner”) will receive a trip package for two (2) people (Winner and one (1) guest (the “Guest”)) to Paris, France, which includes:
 - Round-trip, main cabin air fare for Winner and Guest to Paris, France from a major airport

within the 50 United States nearest the winner's residence as determined by Sweepstakes Sponsor, arriving in Paris on Tuesday, August 6, 2024 and departing on Monday, August 12, 2024.

- Six (6) nights accommodations at Hôtel Montalembert, based on a single room with double occupancy.
- Two (2) tickets to each of the following six (6) Olympic Games events (each, an "Event" and collectively, the "Events"):
 - o Marathon Swimming | Men's - 10km
 - o Athletics | Men's/Women's - Finals
 - o Breaking | Men's - Final
 - o Boxing | Men's - Semi-finals, finals / Women's - Semi-finals
 - o Beach Volleyball | Men's/Women's - Semi-finals (2 matches)
 - o Closing Ceremony.
- Access to Salon 24 Hospitality Lounge during the Events;
- Ground transportation to/from destination airport and hotel;
- Ground transportation to/from hotel and Events; and
- Approximately \$22,000 (to be awarded in the form of a check) to be used towards winner's income tax responsibility.

The ARV of Grand Prize: \$72,296. The ARV may vary based upon dates of travel and point of departure. The approximation listed above assumes Sweepstakes Sponsor provides a check totaling 42.35% of the trip's retail value that can be used towards the winner's income tax liability ("Income Tax Gross Up"). This Income Tax Gross Up amount compared to the actual tax liability may vary and is dependent on the final value of prize, which may fluctuate depending on travel arrangements and departure location; in the event of any discrepancy between the tax liability and the Income Tax Gross Up amount provided by Sweepstakes Sponsor, the Winner will be responsible for any difference. - e. Trip certificates are not valid with Miscellaneous Charge Orders or Prepaid tickets.
- f. Trip certificates cannot be sold or transferred. Purchased certificates are subject to confiscation and you will not be allowed to travel. Only original certificates will be accepted. Certificates will not be replaced. Void if altered.
- g. Travel must be roundtrip.
- h. Reservations must be made, and ticket issued prior to departure.
- i. Delta Vacations must make all reservations and issue all travel documentation.
- j. Each certificate may only be applied towards one passenger and one guest.
- k. Any unused portion of the certificate will not be refunded and cannot be used towards another booking or another service component.
- l. Checked luggage fees may apply and are the sole responsibility of the recipient. Fees are charged each way and are subject to change. Refer to delta.com for current rates.
- m. Changes to reservations, once made, are not permitted.
- n. A per ticket surcharge will apply for paper tickets issued in markets where electronic ticketing is available.
- o. Substitutions will not be allowed.
- p. Space is subject to availability.
- q. The individual redeeming each certificate must be 18 years of age or older.
- r. SkyMiles mileage credit and/or MQDs will not be awarded.
- s. Flight schedules are subject to change without notice.
- t. Delta Vacations is the final authority on the interpretation of these rules and reserve the right to change these terms and conditions without prior notice.
- u. Standard Delta Vacations Terms and Conditions apply, and are outlined during the booking process; other airline restrictions may apply.
- v. The destination may charge taxes or fees not covered by Delta Vacations.

Photo identification and credit card or cash deposit may be required at any time for incidental charges (e.g., room service, use of telephone/IT services, laundry and all other optional extra services not provided in the Grand Prize). All hotel reservations are based on availability. Accommodations are subject to availability at time of reservation. Blackout dates, advance booking requirements and travel restrictions may apply. Availability is subject to factors such as weather, seasonality and space availability. Reservations are subject to availability. If weather or other incident or conditions beyond the control of the Sweepstakes Sponsor affects the ability for Winner and Guest to redeem any portion of prize during the scheduled date and time, then the Sweepstakes Sponsor shall have no further obligation to the Winner and/or Guest other than to supply the remaining elements of the prize package minus the unused portion of prize. Salon 24 hospitality is not available for sports sessions taking place outside the Paris metro area. Access is subject to is subject to factors such as weather, seasonality and space availability. Amenities within the salon are subject to change.

Delta Vacations, LLC is the sponsor of this Sweepstakes but is not a sponsor of Team USA. Delta Vacations is a wholly-owned subsidiary of Delta Air Lines, and only Delta is a sponsor of Team USA. Delta Vacations has no relationship to the Olympic/Paralympic entities.

Sweepstakes Sponsor is not the provider of the Events, which are managed or controlled by an independent third party, and Sweepstakes Sponsor has no power to manage or control the operations of any third-party provider. Sweepstakes Sponsor makes no guarantees or warranties about Event Ticket(s) or an Event itself. Sweepstakes Sponsor reserves the right to substitute a prize of equal or greater value at its discretion. 6. **WINNER SELECTION; RANDOM DRAWING:** The potential Winner will be selected in a random drawing on or about **Thursday, April 25, 2024** from among all eligible Entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sweepstakes Sponsor whose decisions are final.
7. **WINNER NOTIFICATION & VERIFICATION:** On or about **Thursday, April 25, 2024**, the potential Winner will be notified by the Sweepstakes Administrator via email, and will be required to sign and return, within three (3) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Winner to furnish their Social Security Number for the purpose of tax reporting (as required by law) and a background check (as described below). Guest of Winner will also be required to sign a Travel Companion Liability & Publicity Release and furnish their Social Security Number for the sole purpose of a background check (as described below). Travel Companion Liability & Publicity Release must also be returned within three (3) days of Sweepstakes Administrator's notification to the potential Winner. Non-compliance will result in disqualification and an alternate winner may be selected.

Winner and Guest will be required to submit to a background check to confirm eligibility and help ensure that the use of any such person in advertising or publicity for the Sweepstakes will not bring the Sweepstakes Affiliated Entities into public disrepute, contempt, scandal or ridicule or reflect unfavorably on the Sweepstakes or Sweepstakes Sponsor, as determined by Sweepstakes Sponsor in its sole discretion. If a prize notification or prize is returned as undeliverable, or if Winner is found to be ineligible or not in compliance with these Official Rules, that Winner will be disqualified, and the prize may be awarded to an alternate winner in a separate random drawing. If Sweepstakes Sponsor is unable to determine and verify a potential winner after repeated alternate drawings or if Sweepstakes Sponsor fails to receive a sufficient number of entries to correspond to the number of prizes available to be awarded, Sweepstakes Sponsor reserves the right to not award such prize(s).

8. **PUBLICITY RELEASE:** Except where prohibited by law, entry and acceptance of prize constitute permission to use winner's name, travel agency's name, prize won, hometown, likeness, video recordings, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.

If, for any reason, the Sweepstakes cannot be run as planned, Sweepstakes Sponsor may disqualify any suspect entries or individuals from the Sweepstakes and any promotion it sponsors and (a) suspend the Sweepstakes and modify the Sweepstakes to address the impairment, then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; and/or (b) award the prize at random from among the eligible, non-suspect Entries received up to the time of the impairment.

GOVERNING LAW AND LIMITATION OF LIABILITY: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Sweepstakes Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Georgia, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.
